LIABILITY & MEDICAL RELEASE

I do voluntarily authorize **the organizers**, their representatives, agents, servants, volunteers, and employees to obtain routine or emergency diagnostic procedures and/or routine emergency medical treatment for the named person as deemed necessary in medical judgment.

I agree to indemnify and hold harmless **the organizers**, their representatives, agents, servants, volunteers, and employees for any and all claims, demands, actions, rights of actions, and/or judgment by or on behalf of the named person arising from or on account of said procedures and/or treatment rendered in good faith and according to accepted medical standards.

ASSUMPTION OF RISK: I hereby acknowledge that there are inherent risks, dangers and hazards when participating in activities held at or sponsored by Yukonconstruct Society, including the use of various tools associated with design, experimentation, fabrication, construction and other related activities. I understand that participation in such activities and the use of such equipment may result in injury, illness, death or damage to personal property. These risks and dangers may be caused by other participants, or by accidents, acts of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes and may include, but are not limited to: electrocution, burns, impalement, injury from slips or falls, etc.

RELEASE OF LIABILITY: I hereby release Yukon Women in Trades and Yukonconstruct Society and its members, officers, agents, and board members from any action whatsoever arising out of any damage, loss or injury to the named participant or their property while upon the premises, or while using any equipment of the organization or others, or while participating in any of the activities contemplated by this agreement; whether such loss, damage, or injury results from the negligence of the corporation, its members, agents, or from some other cause.

COVENANT NOT TO SUE: I hereby agree never to institute any suit or action at law otherwise against Yukonconstruct Society, its members, officers, agents or board members; nor to initiate or in any way assist the prosecution of any claim for damages or course of action which myself, my heirs, my executors or my administrators hereafter may have by reason of injury to the named

participant or to their property arising from the activities contemplated by this agreement.

THIRD PARTY INDEMNIFICATION: I hereby agree to indemnify, save and hold harmless Yukonstruct Society, its members, officers, board members, or agents from any and all losses, claims, actions, or proceedings of every kind and character which may be presented or initiated by any other persons or organizations and which arise directly or indirectly from the named participant's actions while engaged in the activities contemplated by this agreement.
